**Background** – The Koala Genome Survey dataset is managed by the University of Sydney (**We/Us/Our**) on behalf of the many organisations and individuals who have contributed samples (**Sample Provider**) and with funding and support from the NSW Government, the Australian Government, Illumina, Ramaciotti Centre for Genomics and Amazon Web Services Open Data Sets Program (**Supporters**).

**You/Your** means the individual, entity or organisation accessing the Dataset.

Party/Parties mean you and us.

## **Terms and Conditions**

**Access** - We use reasonable endeavours to maintain access to the Dataset and may, from time-to-time terminate or restrict access to the Dataset.

**Compliance:** You must ensure that you use the Dataset only in accordance with these Terms and Conditions and in compliance with all applicable laws.

**Permitted Use**: On behalf of the Sample Providers, we grant You a non-exclusive, worldwide, royalty-free, non-sublicensable, non-transferable licence to copy, extract and use all or part of the Dataset for Your internal non-commercial purpose (including but not limited to research, study, analysis, policy development) (**Authorised Purpose**).
